
To apply for or renew a full-service library card, please visit any FBCL location during business hours. You MUST provide one of the following forms for valid photo ID that is not expired:

About the TSLAC:

The Texas State Library and Archives Commission has been serving the people of Texas for more than a century.

There has always been an official library and archives of Texas. The State Library and Archives Commission mission is also to ensure that citizens have information they need to lead informed, productive, and fulfilled lives.

What they do:

- **Archives and History:** TSLAC preserves the archival record of Texas, supports research, and makes primary resources available to the public (<u>Archives and Information Services</u>)
- **Libraries and Learning:** Assist public, academic, and school libraries across the state in meeting the needs of their communities and students (<u>Library Development and Networking</u>).
- Access to Public Records: TSLAC is responsible for helping public agencies maintain their public records (State and Local Records Management).
- **Reading Services:** We support the reading needs of thousands of Texans with disabilities preventing them from reading a standard book (<u>Talking Book Program</u>)

TBP Youth Services: Find resources for youth reading programs, and book lists.

<u>Online Exhibits:</u> Browse digital versions of the lobby exhibits going back over ten years, plus special online exhibits on topics such as historic flags of Texas, Texas state parks, and the collection of Texas Treasures, including the Texas Declaration of Independence, Travis's letter from the Alamo, and much more.

<u>Texas Digital Archive:</u> The TDA manages, preserves, and facilitates access to the electronic records collections of the Texas State Library and Archives Commission, including those transferred by state agencies or digitized by the State Archives. All records visible in this portal are unrestricted and available for public use.

<u>Genealogy Resources:</u> The Genealogy Collection at the Texas State Library and Archives Commission includes vital statistics indexes, city directories, county records, publications such as printed family and county histories, a variety of Texas government records, federal census schedules and many other resources to help you compile your family history.

<u>E-Read Texas</u> brings electronic books and audiobooks to Texans served by small community libraries in all parts of the state. E-Read Texas provides more than 18,000 downloadable e-books and audiobooks and a mobile e-reader application that make it possible for all Texans served by public libraries to access e-books. The E-Read Texas collection primarily includes adult fiction and popular non-fiction and is most appropriate for an adult audience. All content can be accessed using the SimplyE mobile application.



In the News:

Texas Center for the Book Announces 2023 Texas Great Read Titles

The Texas Center for the Book at the Texas State Library and Archives Commission has chosen <u>Nell Plants a Tree</u> by Anne Wynter, illustrated by Daniel Miyares, as the 2023 Texas Great Read Youth Selection and <u>West with Giraffes</u> by Lynda Rutledge as the 2023 Texas Great Read Adult Selection. Every year, the Library of Congress asks each state Center for the Book to select titles that represent the state's literary landscape to highlight at the National Book Festival. The event showcases the importance of books and reading. The 23rd Library of Congress National Book Festival will take place on August 12 in Washington, DC, with varied offerings online. Library Legislation during the 88th Session*

The controversy over what children have access to was a topic of debate over this legislative session. *HB* **900** was filed as a way to keep explicit content out of the hands of school children. The bill passed the legislature and becomes effective on September 1, 2023.

What HB 900 does:

• Defines sexually explicit and sexually relevant material and requires library material vendors (any entity that sells library materials to a public school in Texas) to assign sexually explicit and sexually relevant ratings to any material the vendor determines meet the law's definitions. The Texas State Library and Archives Commission (TSLAC) is required to adopt standards for collection development, to be approved by the State Board of Education (SBOE) that school districts are required to follow when developing and implementing collection development policies. The mandatory TSLAC collection development standards apply to materials in school libraries and in classroom libraries. (Texas Library Association)

Key Points in HB 900:

- School districts and librarians operate under existing, approved procurement, collection development and reconsideration policies as 2023-2024 school year begins.
- Vendors, not librarians or any other district staff, are responsible for rating library materials.
- Ratings are only applied to material vendors determine meet the definitions of sexually relevant or sexually explicit
- Material rated sexually explicit by vendors must be removed from the collection.
- Parental consent for materials rated sexually relevant needed when vendors provide those ratings.
- Reconsideration requests follow current, approved district policies. (<u>Texas Library Association</u>)

Timeline for Implementation:


June 13, 2023	Signed by Governor Abbott
September 1, 2023	Effective date
January 1, 2024	TSLAC mandatory collection development standards, approved by SBOE, final
April 1, 2024	Vendors provide initial list of materials they rated sexually explicit or sexually relevant to TEA Materials rated sexually explicit must be removed from school libraries
September 1, 2024	Vendors provide updated list of materials they have rated to TEA
January 1, 2025	School districts review vendor rated sexually relevant material in their current collection and post a report on their website

When I came to the Texas House I was determined to make a difference in the way Texans access healthcare. One of the ways that I accomplished this was to become a coauthor on <u>HB 12</u>. This piece of legislation would allow people who have given birth to keep their Medicaid benefits through the first 12 months postpartum. Texas remains the state with the highest rate of maternal mortality in the nation and this bill would help to give new mothers the start they deserve.
