Without such organizations serving rural districts across the state, it would be easy for education policy to be dominated and dictated by large, urban

and wealthy districts. These organizations provide small and mid-sized communities with a voice in policy decisions, and I am grateful for their recognition and assistance.

Mount Vernon Music (MVM). The Mount Vernon Music Association received a \$600 grant from the Texas Commission on the Arts for its 2021-2022 season. MVM used these



funds to support its programming in January/February to bring Texas Touring Roster pianist Evan

Mitchell to the area. Without such support, MVM could not bring such outstanding musicians to perform in Northeast Texas.

Congratulations to and a big "thank you!" to MVM for all their hard work.

Prescribed burn plans announced. The Texas Parks and Wildlife Department (TPWD) recently informed my office that it plans to conduct prescribed burns in the White Oak Creek



Wildlife Management Area between February and April 2022. A public notice about the burns will be published in the Mount Vernon Tribune

prior to the actual burn period. Local officials have also been notified to ensure that appropriate emergency services and local fire departments are on notice and prepared for any responses that might be needed.

Around the Capitol.

HHS news on recalled baby formula. The Health and Human Services agency recently announced that there is a recall of powdered baby and toddler formulas with brand names Similac, Alimentum and EleCare. If you use powdered formula, check to see if your formula has been recalled at similacrecall.com. If recalled, do NOT use it.

TRS received additional funding for its health insurance programs. In October 2021, the legislature passed SB 8 (87-3) that provided TRS with \$286 million in federal funding (ARPA) to reimburse COVID-19 expenses for TRS-ActiveCare (for active employees) and TRS-Care (retired employees). The legislature directed TRS to prevent premiums in these two programs from increasing due to coronavirus-related claims. Please note that the TRS board will set premiums for TRS-ActiveCare in April.

TRS-Care retiree premiums **did not increase** this year and have remained at the same levels since 2018. As a result of SB 8, eligible retirees enrolled in TRS-Care will receive **a one-time payment of \$448.12** that will be issued in March 2022. This is in addition to retirees' monthly TRS annuity and the <u>supplemental payment</u> (*capped 13th check*) provided in January of 2022 to eligible retirees. Texas Prepaid Tuition Program Enrollment Deadlines Approach. Texas families can lock in today's cost of undergraduate resident tuition and school-wide required fees at Texas public colleges and universities by enrolling their children in the tax-advantaged Texas Tuition Promise Fund® before the close of the current general enrollment period on Feb. 28. Complete plan information — including residency and other requirements, current prices, enrollment forms and more — is available online at TuitionPromise.org, or by calling 800-445-GRAD (4723), option 5. To enroll children younger than 1 in the program at 2021-22 prices, the deadline is July 31. The next general enrollment period begins on Sept. 1, with new contract prices based on Texas public college tuition and school-wide required fee costs for the 2022-23 academic year. Go to the Texas Tuition Promise Fund website for information about how to register to attend upcoming webinars.

Nominate a student volunteer. Do you know a student who goes above and beyond to make his or her school, other students and community better? The Texas State Board of Education (SBOE) recently announced an opportunity to nominate such a student for an

award and recognition in the 2022 Student Heroes Award. The Student Heroes Award program recognizes Texas public school students in Pre-Kindergarten through high school who voluntarily work to assist and/or

> benefit their fellow Texas students. Award requirements include the following:

- The service, assistance, and/or good deed must be voluntary and not part of any curriculum, graduation requirement, class, or community project.
- The service, assistance, and/or good deed must benefit other students in Texas, either individually or collectively.
- The benefit may be to students of one campus, district, or community.

Nominations will be accepted through March 31, 2022, at 5:00 p.m. (CDT). Recipients of the awards will be announced in June. A plaque and medal will be awarded to each Student Hero by his or her State Board of Education member. Nomination forms and program guidelines are available here.
