Summer 2022 Legislative Update

Dear Neighbor,

As we quickly go through the 87th Interim and approach the next legislative session, I wanted to share with you a few updates, information, and resources that are important to House District 115.

In 2021, the Legislature conducted its 87th Legislative Session and three additional special sessions coming to a conclusion in October. Since then the Texas House of Representatives has assigned charges to all committees to study and hear testimony. Numerous committee hearings have taken place and will continue through the year. Additionally, new committees have been established to look more deeply into health care reform, criminal justice reform, and youth health. When the next legislative session begins in January 2023, the character of our state and how we respond to the conditions of the last few years will be a top priority. The education of Texas children is one of the most important things the state does. Yet, today we are at an impasse on what our students should learn and how our teachers should teach. Many of the school districts in HD 115 are asking for input from citizens as they examine current policies and practices. Reach out to your mayor, city manager, and council member and let your voice be heard on these policies that directly affect us all. Additionally, the COVID-19 pandemic has revealed the utmost importance of accessible, affordable health care. As such, this continues to be one of my top priorities in the Legislature and our team will continue to push to increase Texans' access to care.

Another issue that I, and many colleagues, will push to address is the continuation of mass shootings in Texas. On Tuesday, May 24, 19 beautiful children and 2 dedicated teachers were taken from this world in Uvalde, Texas. Our hearts break for the families of the victims and the entire Uvalde community. Unfortunately, our state has seen too many mass shootings and attacks in grocery stores, places of worship, and schools. This tragedy and others were preventable, and I will continue to fight to ensure that we do not see another one in the future.

Before the next session, there will be a midterm election this upcoming November. The Texas Legislature updated voting laws and went through the redistricting process in 2021, so it is important to check your voter registration, new districts, and vote-by-mail regulations. HD 115 went through some boundary changes as well. Our team welcomes you, and we look forward to getting to know all our new constituents in the coming months.

As we continue to navigate through this year, the HD 115 team wants to remind you that we are here to help. If you are in need of assistance or have questions, please do not hesitate to reach out to our office. As always, it is an honor and privilege to represent the residents of House District 115. I look forward to hearing from you and continuing to serve as your state representative.

LEGISLATIVE INTERIM UPDATE

INTERIM CHARGES

Earlier this year, Speaker Dade Phelan assigned interim charges for all House Committees to study for the remainder of the year. Each committee will hold hearings to study the assigned charges and compile a report at the end of the year with their findings and recommendations for the next session. As a member of the House Appropriations Committee and the Judiciary & Civil Jurisprudence Committee, Rep. Johnson will hear from experts and public testimony in those areas. The Appropriations Committee will focus on the implementation of various appropriations bills passed in the 87th session, revenue bonds to fund capital projects at public institutions of higher education, long-term capital needs of the Texas Parks and Wildlife Department, monitor funds from the Flood Infrastructure Fund, and review the use of federal funds by the Texas Education Agency and local school districts. The Judiciary & Civil Jurisprudence Committee will study solutions to improve judicial efficiency of the state court of appeals, evaluate the use and types of guardianships, study the operations of specialty courts, and review procedures relating to jury service eligibility.

In addition to the standing committees, two new committees were created to examine the state's criminal justice and health care systems. The Interim Study Committee on Criminal Justice Reform will monitor recent changes made to the state's bail system and examine policing, criminal procedure and due process,

88th LEGISLATIVE SESSION

The next legislative session will begin on January 10, 2023, and our team is already preparing. Rep. Johnson has been meeting with constituents, local city officials, school districts, businesses, and advocates to better represent District 115. Many bills filed in session are a collaboration between members and individuals or organizations in their district. We would love to hear what issues are most important to you as we develop our legislative agenda.

transparency in the grand jury process, the appropriate age range for the juvenile justice system, and opportunities to reduce recidivism. The House Select Committee on Health Care Reform will study the costs of Texas Medicaid, monitor the implementation of current price transparency requirements, evaluate fiscal positive options to ensure Texans have access to health care, study ways to improve outreach to families with children eligible for Medicaid or CHIP, and examine the impact of delayed care on the state's health care delivery system.

After the tragic shooting at Robb Elementary School in Uvalde, Texas, Speaker Phelan established an investigative committee to conduct an examination into the circumstances surrounding the shooting. The committee possesses the power of subpoena and is authorized to conduct deposition and initiate discovery. The Select Committee on Youth Health & Safety and the Homeland Security & Public Safety Committee were also assigned additional joint interim charges on the issue.
