# **Committee Assignments Are Out**

# Select Committee on Public Health Care Reform

The Speaker was apparently pleased with the work and the progress of our interim committee from the 87th Legislative Session, as he decided to continue our work in the 88th Session, naming Sam Harless as Chairman of the Select Committee on Public Health Care Reform. Vice Chair for the committee is another experienced legislator and medical professional Donna Howard from Austin. Vice-chair Howard is new to the committee and has a Bachelor's degree in nursing and a Master's degree in health education. Continuing their service on the committee is Dr. Tom Oliverson, an anesthesiologist, and Dr. Greg Bonnen, a neurosurgeon. Stephanie Klick, who has a Bachelor of Science degree in Nursing with decades of practical and consulting experience in the field, is also on the committee along with James Frank, a North Texas business owner who is Chairman of the Human Services Committee.

Many of these are senior legislative members who have, or currently are in leadership positions on other related committees. We are fortunate to have so many experienced members joining us as we continue this work on through the end of the 88th Session.

We have hired committee staff, with Greer Gregory joining us as our senior Committee Clerk. Greer has clerked in a committee previously and recently completed law school at the University of Texas before going to work for the Texas Health & Human Services Commission as a policy analyst in their government relations office.

Representative Harless was also assigned to the Homeland Security & Public Safety Committee again this year and Speaker Phelan also created a new Select Committee on Community Safety. This new committee was created to focus on legislation related to the possession, sale, and transfer of firearms and ammunition and the associated criminal offenses and penalties. Chairman Guillen., who also chairs the Homeland Security & Public Safety Committee, serves as Chairman on this committee and it contains many of the same members.

Representative Harless was also assigned to the Licensing and Administrative Procedures and House Administration Committees

# **Housing Project In The District**

# **Upcoming Oakwood Trails Apartment Project On Louetta**

It seems that the developer (Lincoln Avenue Capitol) is still planning on moving forward with the housing project in the 4200 block of Louetta. We have confirmed this is a 4% tax credit application, which means that Rep. Harless doesn't have the ability to impact its approval of the application with TDHCA. State Representatives only have the ability to influence 9% tax credit applications.

However, during Representative Harless' multiple meetings with the developer he expressed the concerns that the community had in the location and design of the project. In good faith and out of respect for the community the developer notified us that they are making the following changes to the project:

• Restricting the property to seniors age 62 and over as opposed to 55 and over. All residents must be 62+ under the revised program.

• Removed a floor of apartments from each building, reducing the 4-story buildings in the east down to 3 stories and reducing the 3-story buildings in the west down to 2 stories, thus lowering sight lines into neighboring homes.

• In reducing the building heights, the overall number of apartment units was reduced from 254 down to 203.

• The reduction in units allowed for the removal of a row of parking along the western property line which will allow for additional existing trees to be retained, increasing the buffer between the neighborhood and subject property.

• The number of floors in the western portion of the site will be the same number of floors as the singlefamily homes in the community and the additional tree buffer should further assist in the effort to provide more privacy and improves the sight-line for homes of community residents on the West side of the project.

• Since the community meeting in August, the development team has met with the Harris County Flood Control District – Watershed Management Department and Harris County Floodplain Administrator to review the proposed plan and ensure the site has proper detention and floodplain mitigation.

I know that there is still a lot of community opposition to this project, but again due to the nature of their application there really isn't anything that Rep. Harless will be able to do to stop it. I do want to

emphasize though the importance of these changes being made by the developer. They were in no way obligated to make any changes to their project, but after listening to Rep. Harless' concerns and because of their desire to respect the community and wanting to be good neighbors they've decided to make these changes.


This property would be located across the street from the old gym and on the south side of the Louetta with construction planned for Summer 2023 and a two year completion timeline.

# **HCESD 16 News**

Klein Fire Department has started 2023 with a 31% increase of incident responses over 2022. In December, we responded to 5 structure fires in our territory and 6 additional structure fires as mutual aid with six of our neighboring departments. The number of medical responses continue to set record levels month over month.





Cardiac arrest occurs when the heart stops pumping blood around the body. When someone has a cardiac arrest, the earlier they are defibrillated the better the chance of survival. Once the heart stops beating effectively the flow of oxygenated blood around the body reduces and eventually stops. Vital organs will start to die when they lose their supply of oxygen rich blood. The brain for example will start to die within minutes. Early CPR and early defibrillation are extremely important following a cardiac arrest. The earlier effective CPR and defibrillation is received, the higher the chance of survival.

Klein Fire Department assists Harris County ESD 11 Mobile Healthcare as a medical first responder when seconds count. Last calendar year, our mutual aid resulted in 20 ROSC's of the total 78 cardiac arrests we responded to in 2022. Return Of Spontaneous Circulation (ROSC) is the resumption of a sustained heart rhythm that perfuses the body after cardiac arrest and for the 28.6% of our patients who have survived a cardiac arrest, is a celebratory term.

While we always strive to improve response times, the community can also assist in greatly increasing the chance for ROSC. The first way to assist is the early recognition of cardiac arrest, as this is a key step in initiating early treatment. The second way is having regular recertification in bystander CPR. Lastly, access to an AED and the ability to use it properly are critical - for each minute defibrillation is delayed, the odds of survival are reduced by approximately 10 percent.



Klein Fire Department celebrated the Grand Opening of Station No. 6 on February 25<sup>th</sup>. We would like to thank the following people who helped make it special; The Honorable Sam Harless for his opening remarks, Klein Cain ROTC Cadets under the Command of Cadet Sergeant Major Ean Beretta for our flag raising ceremony, Klein Cain senior Jordan Harrold for his rendition of our National Anthem, and all the members and families who turned out to celebrate.

The Klein Fire Department is rated ISO Class 2 and provides Fire Suppression, Rescue, and Medical Emergency Assistance to a resident population of 173,549 residents covering the Spring/Klein area and encompassing approximately 49 square miles.

# Harris County ESD No. 29 Receives Top ISO Rating

Harris County ESD No. 29 (Champions) is excited to announce that the District's Insurance Services Office (ISO) rating has improved to a **Class 1** effective September 1, 2022. Previously, ESD 29 was classified as an ISO Class 2/6. Class 2 in areas with fire hydrants, and class 6 in areas without fire hydrants. ISO creates Public Protection Classification ratings (PPC) for communities to evaluate how well-equipped fire departments are to put out fires.

The best rating from ISO is a 1, while the lowest is a 10. The fire department score makes up 60% of the rating. The remaining 40%, and the most challenging portion of the rating to improve, is the available water supply. Typically, the water used to combat a fire comes from fire hydrants. In 2017, to assist with water supply in areas void of fire hydrants, ESD 29 purchased a 3,000-gallon water tanker truck. Additionally, ESD 29 receives water tanker aid from neighboring fire departments. With these improvements and the opening of Fire Station 12 on Cutten Rd in 2020, ISO re-evaluated ESD 29's PPC rating.

ISO provides PPC ratings to insurance companies to help set property insurance premiums. Many insurance companies utilize the ISO ratings, but some do not. You should contact your insurance company to make them aware of this improvement to ESD 29's PPC rating. Please remember taking the extra steps to fireproof your home or business is still important. Installing smoke alarms and carbon monoxide detectors and keeping portable fire extinguishers ready is a significant first step. The Infrastructure Division administers and manages Precinct 4's Capital Improvement Projects Program. The CIP program includes road expansion projects, traffic signals and intersection improvements, and traffic management systems designed to improve mobility and air quality.

The Infrastructure Division also oversees the Child Safety Fund which is used to provide warranted school zone flashing warning signals in compliance with Precinct 4's criteria, the installation of a warranted traffic signal system facilitating the movement of traffic around a school facility to promote student safety.
