Since I last wrote, we have reached the point in session where we can no longer hear bills on second reading in the Chamber. Any House bill that did not make it through our Chamber by midnight on Thursday, May 12, will not pass this session. You can understand why this week has been so exciting. We will now focus our attention to the bills coming over from the Senate. Their bills will now go through our process and ours must also go through theirs.

I am happy to say that so far, I have had one bill make it to the Governor Perry's office. HB 571, which deals with the water quality of our drinking water in Northeast Harris County, is waiting for his approval. I hope he will find this issue just as important as I do, especially for the people of House District 127.

I wish I could say that the hard part is over, but now is when the real work begins. We have a little more than two weeks to finish the business of the people of the State of Texas. I intend to see good policy decisions made in our last days in Austin and am honored to have your support on this journey.
