Survivors With Extenuating Circumstances May Still Apply for Disaster Assistance After the Nov. 30 Registration Deadline

Late applications will be reviewed for possible approval, but applicants will have to submit a letter explaining why they were not able to apply before the deadline. After registering late, a notification will be sent to the applicant:


- After receiving the notification, the applicant must submit a letter to FEMA that includes an
 explanation for the late application, with supporting documentation.
- Extenuating circumstances may include: hospitalization, death of an immediate family member, or personal or business travel.
- Explanation letters must be submitted (postmarked if sent via mail) within 60 days of the notification letter from FEMA.
- FEMA will review for approval or denial.

SBOE Long Range Plan for Public Education

Work is under way to create a new Long-Range Plan for Public Education, which is expected to establish goals for Texas public schools through the year 2030.

The State Board of Education (SBOE), which under Texas law is required to adopt a plan, recently appointed the Long-Range Plan for Public Education Steering Committee, based on the advice of The Boston Consulting Group. This <u>18-member steering committee</u> is made up of state board members, various stakeholder group representatives and representatives from three state agencies.

The steering committee will recommend long-term goals for Texas schools and will identify the strengths, weaknesses, opportunities, and challenges of the system.



SB 4 - Sanctuary Cities Update

Prior to the 85th Legislative Session, several governmental entities in Texas adopted or were considering adopting "sanctuary city" policies that purposefully hindered or prohibited local law enforcement cooperation with U.S. Immigration and Customs. These policies also prohibited officers from inquiring about a person's immigration status.

The Texas House of Representatives passed legislation in 2017 that prohibits sanctuary cities policies in Texas.

 Senate Bill 4 ensures federal and state immigration laws that are already on the books are followed and requires the laws be enforced by prohibiting local entities from adopting sanctuary cities policies which pose harmful concerns to their citizens.



- The bill enhances public safety by requiring local entities to cooperate with Immigration and Customs Enforcement (ICE) to remove dangerous criminals who are in the state illegally.
- In addition, local law enforcement has the ability to inquire about the immigration status of detained or arrested individuals.
- If officials don't comply with federal authorities, they could face jail time and penalties that exceed \$25,000.

Soon after being signed into law by Governor Abbott, cities, local governments, and immigration rights groups began suing the state arguing Senate Bill 4 would target minorities. A federal court in Austin temporarily stopped enforcement of the bill on August 30th, ruling that it was potentially unconstitutional. Later in September, the 5th U.S. Circuit Court of Appeals allowed the portion of the bill requiring Texas counties to comply with detention requests from U.S. Immigration and Customs Enforcement to go into effect. The 5th Circuit heard arguments on the case on November 7th. It's not clear when the panel will issue a decision. The ruling could potentially be appealed to the U.S. Supreme Court.

2018 Texas Fatherhood Summit

The 3rd Annual Texas Fatherhood Summit is set for next summer, **Friday, June 29, 2018** at the AT&T Executive Education and Conference Center in Austin, Texas. The Summit's theme is Engaging Communities, Strengthening Families, putting a lens on why and how the inclusion of policies and programs that support fathers at the community level strengthens the entire family, as well as the communities in which they live.

The Texas Fatherhood Summit at The University of Texas at Austin brings together hundreds of public and private sector professionals who seek research-based best practices and innovations to best support dad, mom, and their children. The 2018 Summit is especially relevant for policymakers at all levels of government, community leaders, nonprofit organizations, program leaders, and local business professionals.
