State budget. The only bill that any Texas legislature has to pass is the state budget for the next biennium. Prior to each session, the comptroller is required to issue the state's Biennial Review Estimate (BRE), which Comptroller Glen Hegar released the day before the session convened. Hegar told lawmakers they will have \$104.9 billion in general state revenue, which is almost \$3 billion less than available (\$107.7 billion) in 2015. Though not good news, Hegar reminded lawmakers that our state's economy is much more diverse than previous downturns, and he has projected moderate growth in years to come. This news just confirms that our legislature's philosophy of conservative planning and budgeting has served our state well and will be especially important this year.
