

Around the District. NETT recommended for funding. The Texas Parks & Wildlife (TPW) recently announced that the Northeast Texas Trail (NETT) is being recommended for almost \$1 million in funding (\$974,400) from the National Recreational Trails Fund to repair bridges and railings, erect new signage, clear and grade areas and road crossings. The



following parts of NETT are being recommended to receive this funding, but they must receive final approval by the TPW Commission prior to receiving the grants:

- Clarksville NETT;
- Red River County NETT;
- Northeast Texas Trail Coalition NETT;
- Avery NETT; and

Around the Capitol. Legislature adjourns sine die. The regular session of the 86th Texas Legislature adjourned on May 27, 2019. Unless the governor calls a special session, the legislature will not gather again until the 87th

legislature convenes on January 12, 2021. This edition of my enewsletter focuses on the major priorities of this session including school finance, property tax reform and the state budget for 2020-21.

Property tax and school finance reform. At the January start of this session, the state's elected leadership (governor, lieutenant governor and Speaker of the Texas House of Representatives) announced it was their intention that this year's session would tackle the root causes

of rising property taxes, which was declining state support for our public education system and increasing property values. Over the last decade, the state's share of funding our public schools declined from approximately 46 percent to 38 percent, which shifted the burden of school funding to local taxpayers in school districts causing dramatic increases in local property taxes for homeowners and businesses. This year's property tax reform legislation was Senate Bill 2, and the school finance bill was House Bill 3. Changes in statutes from both bills were needed to accomplish the goals of reducing homeowners' and businesses' property taxes and to direct more funding to the classrooms. Here is a highlevel summary of these key pieces of legislation:

**Property taxes - SB 2** - lowers property taxes by increasing the state's share of public school funding as outlined below:

- Establishes a 3.5% tax cap on cities and counties, which means these local governments cannot increase their tax revenue above that rate without an automatic election for voter approval;
- Provides over \$5 billion in statewide property tax relief;
- Lowers school property tax rates by an average of 8 cents in 2020 and 13 cents in 2021;
- Provides an additional 2.5% tax compression starting in 2021;
- Ensures taxpayer dollars are used responsibly by requiring districts to conduct efficiency audits before going to voters with a tax increase; and,
- Increases the state's share of education funding from 38% to 45%

**School finance** - **HB 3** - puts **\$4.5 billion** more money into classrooms to accelerate student achievement as outlined below:

- Establishes a 2.5% tax cap on school districts, which means school boards cannot increase their tax revenue above that rate without an automatic election for voter approval;
- Significantly increases the Basic Allotment per student from \$5,140 to \$6,160;
- Funds full-day Pre-K for low income students;
- Adopts high-quality K-3 reading standards so students read at grade level by 3rd grade;
- Creates the first dyslexia identification program in Texas history;
- Accelerates student achievement via College, Career & Military Readiness

- Funds transportation at a rate of \$1.00/mile and quadruples funding for building and equipping new facilities; and
- Directs more funds to schools with higher concentrations of under-served students, including dropouts, students in special education, and residential treatment facilities.

Employee compensation. An additional \$2 billion in funding was added to provide pay raises for all teachers, librarians, school nurses and counselors. House Bill 3 also directs school districts to use some of their increased funding to provide raises for other staff as well. The Texas Education Agency is currently "crunching the numbers" and will be distributing information to school districts as soon as possible.

Retired school employees. Legislation (SB 12) also passed and funds were appropriated in SB 500 and HB 1 to stabilize the actuarial soundness of the Teacher Retirement System of Texas (TRS) by increasing state and local school district contributions by \$524 million in the 2020-21 biennium. All "regular service" retired

school employees, who retired prior to December 31, 2018, will receive a 13th-month check equal to their current annuity payment not to exceed \$2000. The cost of the 13th-month check to the state is \$589 million. Retired school employees have also been very concerned about increases in their health insurance premiums, which experienced a dramatic restructuring and major cost shifting after the 85th session in 2017. This session, the legislature appropriated \$231 million to TRS-Care that will prevent any increase in retiree health insurance premiums through December 31, 2021.

The bills mentioned above are hundreds if not thousands of pages long, and it will take several weeks to fully comprehend the impact of this legislation before they take effect on September 1, 2019. My legislation. While working with the appropriations and public education committees on the above issues, I was also trying to get the legislation I filed this session across the finish line. I authored 29 House Bills

and sponsored four Senate Bills this year. As of press time, 11 have either already been signed by or sent to the governor awaiting final action. The

deadline for final gubernatorial action is Father's Day, June 16. My June enewsletter will include a final summary about the outcome of my legislation after the governor's signing deadline.
