District Update



Ground Floor Connective. Earlier this month, representatives of several area organizations gathered at the Texarkana City Hall to express appreciation and celebrate that the city has dedicated more than \$25,000 of its portion of the national opioid settlement to pay for a service coordination software called HopeHUB to be used by the local nonprofit Ground Floor Collective that helps families from "crisis to careers." Kristina Rivas-Jones, the Collective's director and co-founder, said she was honored to help lead the HopeHUB initiative and the grant will help

strengthen the work that the collective's community partners have already been doing. "It's going to strengthen those lines of communication between both sides of the state line, and between our organizations, and continue to help us help people move from that crisis, ultimately to that career that provides them a living wage right here in Texarkana," she said. The "partnership between the city and Ground Floor Collective holds potential and promise, empowering families to navigate difficulties with dignity," said Texarkana City Manager David Orr. Marvin Nichols Feasibility Review. The Texas Water Development Board (TWDB) was directed by the legislature last year to conduct a feasibility review of the proposed Marvin Nichols Reservoir. The draft review is scheduled to be posted to the TWDB website (https://www.twdb.texas.gov/) no later than the end of September.

Water availability, or lack thereof, in Texas has always been a big concern considering the state's ever growing population and frequent droughts. The legislature enacted legislation and voters approved in November 2023, the creation of the state's new Texas Water Fund. The funding for this program is distributed among several water specific programs at the TWDB including the Texas Rural Water Assistance Fund; State Water Implementation Fund of Texas (SWIFT); Economically Distressed Areas Fund; and many other loan and grant programs. The TWDB's website states: "The TWDB offers a variety of cost-effective loan and grant programs that provide for the planning, acquisition, design, and construction of water related infrastructure and other

water quality improvements <u>totaling approximately \$35.7 billion</u>." A look at housing in Texas. State comptroller, the Honorable Glenn Hegar, recently released an indepth study of available and affordable housing in Texas: The Housing Affordability Challenge. The report found that in 2023, the state was approximately 306,000 house units short in meeting demand with the greatest shortage in houses that are affordable for middle-income buyers. The report partially attributed the shortage to a lack of robust recovery in the housing market after the financial crisis in 2007-08. The state's ever-increasing population combined with fewer houses being built to keep up with the growth in demand contributed to the dramatic increase in home values between 2020 and 2022. While home values were rising so were interest rates and the cost of property-casualty insurance and property taxes. Texas A&M University's Texas Real Estate Research Center also reported that between 2019 and 2023, median home prices rose 40 percent. All of these factors have contributed to an ongoing lack of affordable, available houses not only in Texas but across a lot of the country. Policymakers at the local, state and federal levels are struggling to find solutions to this problem to ensure there are enough affordable homes available. When the 89th legislature convenes in January, I suspect many proposals to be offered as possible solutions to the state's current housing shortage and property tax challenges. Hopefully, we will be able to agree upon solutions that work best for all Texans in the housing market.

TxDOT teaming up with law enforcement to fight drunk driving. The Texas Department of Transportation (TxDOT) recently released information stating that one person is killed every eight hours in alcohol-related crashes in Texas. TxDOT recently launched its "Drive Sober. No Regrets." campaign in conjunction with the upcoming Labor Day holiday to remind Texas drivers that drunk driving is 100 percent preventable as are the crashes that result when Texans choose to drink and get behind the wheel. TxDOT Executive Director Marc Williams states that "if you plan to celebrate Labor Day by drinking, make sure you arrange a sober ride using a rideshare, taxi, public transit or a designated driver." TxDOT is working with law enforcement agencies across the state as they boost efforts to identify and arrest drunk drivers from August 16 through September 2. Over Labor Day in 2023 according to TxDOT, "there were 334 DUI-alcohol related traffic crashes over the Labor Day holiday weekend, resulting in 14 fatalities and 35 serious injuries." Let's all commit to a safe and sober Labor Day!

Secretary of State Nelson takes measures to stop noncitizens from voting. The Honorable Jane Nelson, Secretary of State (SOS), recently released a statement outlining Texas's efforts to combat illegal voting. The Texas Legislature tightened its voting laws in 2021 and again in 2023 to "prohibit noncitizens from registering and voting in any Texas election." Secretary Nelson went on to say that "providing false information on a voter registration form subjects applicants to criminal penalties, including jail time and a fine. It is a second-degree felony for a noncitizen to vote in Texas." The state also recently announced that it has purged 1.1 million people from the state's voting rolls because they were either dead, their addresses could not be verified or they were noncitizens. I agree with Secretary Nelson who said: "Voting is a sacred right that must be preserved for citizens who qualify under our elections laws." I supported the legislation to strengthen the registration and voting laws and believe that "we need to make it easy to vote, but hard to cheat." These new laws do just that and help ensure the integrity of our elections.

Texas Music Incubator Rebate Program (TMIR). The Texas Music Office recently announced that its tax rebate program for qualifying music venues and festival promoters in Texas, will begin accepting applications for Fiscal Year 2024 from September 1, 2024 through November 30, 2024. The TMIR Program was created in 2021 in Senate Bill 609 to help support the live music industry in communities

across the state. The 88th legislature appropriated \$20.2 million for the program to provide qualifying music

venues and festival promoters in Texas a full or partial rebate of their mixed beverage gross receipts taxes or sales taxes attributable to the sale of beer and wine in the *prior fiscal year (September 1, 2023, to August 31, 2024)* of up to \$100,000.
