With the 86th Legislative Session now complete, I want to once again express my appreciation for your continued trust and support as your elected voice in the Texas House of Representatives. I am incredibly honored to serve as your State Representative in Austin, and I am proud of what we accomplished this session for the State of Texas and specifically, for House District 12.

This session began with the Governor, Lieutenant Governor, and the Speaker of the House calling to prioritize school finance reform, property tax relief, and teacher pay raises. The Legislature worked diligently and was successful in accomplishing these goals, but it did not stop there. The 86th Legislature was also able to provide meaningful improvements in border security, the advancement of pro-life reforms, protection of the Second Amendment, and the passage of a conservative, balanced budget. The changes made this past session will undoubtedly make the state of Texas an even better state to live, work, and to raise a family.

The purpose of this newsletter is to briefly acquaint you with some of the critical issues that the Legislature addressed this regular session. DISTRICT 12 * LEGISLATIVE UPDATE * FALL 2019

* Public School Finance *

House Bill 1, Senate Bill 2, and House Bill 3 work together to provide transformational reform to our public school system while providing some property tax relief to taxpayers. Over \$6.5 billion additional dollars will go to our public school system, which will result in an additional \$1,000 per student each year. Furthermore, the Legislature invested over \$2 billion to go towards teacher pay raises in efforts to retain and attract the best educators for our young Texans. Our public education system is the key to educating the future workforce, and this reform came at no additional cost to the taxpayer.

* Property Tax Relief and Reform *

Property tax relief and reform are top issues for many Texans, and this session the Legislature took meaningful action to protect taxpayers. House Bill 3 provided for over \$5 billion in property tax relief, which will decrease tax rates by an average of 8 cents per dollar in 2020 and 13 cents per dollar in 2021 in House District 12. Senate Bill 2 reformed the property tax system by allowing Texans to vote if a taxing entity wants to raise their taxes by more than 3.5% for most local governments and 2.5% for Independent School Districts. These key pieces of legislation also provided for more transparency in the process, which will allow taxpayers to see who is responsible for any rise in property taxes.

* 2nd Amendment *

The 86th Legislature took great strides in strengthening your second amendment rights. This session we passed legislation that would prohibit Home Owners Associations from restricting firearms and prohibited "no firearms" clauses in leases. We also restored the rights of places of worship to decide whether licensed carry is permitted on their premises. The Legislature also took steps to allow permitless carry for those evacuating from and returning to a disaster area.

★ Pro-Life Initiatives ★

A top priority for the Legislature was continuing to protect the life of unborn Texans. The Legislature dedicated over \$60 million to crisis pregnancy centers and to provide for alternatives to abortion. We also prohibited government from conducting transactions of goods and services with abortion providers and ensured that abortion providers would not receive taxpayer money.

* Disaster Preparedness *

In the wake of Hurricane Harvey, there was a great deal of focus on preparedness and response. We knew Texas needed to be even more prepared for unexpected disasters in the future. The Legislature created a property tax exemption for people affected by declared disasters in an effort to ease the financial burdens of Texans in their darkest hours. We also made sure to improve infrastructure and regional planning efforts to mitigate, control, and recover from floods, and we eased regulatory burdens that slowed response time and debris removal to ensure we keep Texas families safe.

* Limiting Government *

As Texans, we know the importance of small government and individual freedom. Because of these deeply held beliefs, the 86th Legislature passed a fiscally responsible budget that keeps state spending under the constitutional spending limits. We also defended private property rights by ending forced annexation statewide and banned the predatory use of red light cameras in Texas. These initiatives extend freedoms to taxpayers that they deserve.
