Coronavirus Changes the World

Once again, our news is all about the pandemic. It's hard to believe we've been living with the COVID-19 this long. This historic pandemic has affected our lives and businesses beyond measure. The Texas Capitol has been closed for over a month and many people are working from home. Harris County has been living under a "Stay Home" order since March 24th and as Texans, we've adapted to the changes in our personal lives, and businesses and schools remain closed through the end of this academic year. I can't say enough about how well Klein, Cy-Fair, Spring, and Tomball School Districts have transformed their educational models to serve students outside the traditional classroom through innovative distance education. We are blessed to have outstanding school leadership and teaching staff! Many high school and college seniors have had their final school year interrupted, proms, and athletic activities cancelled that will not have that opportunity again. Our hearts go out to them with encouragement that life will not always be like this.

We continue to hear from residents about the difficulties in getting claims filed

through the Texas Workforce Commission and my staff has been successful in helping a number of those who contacted us directly. Another thing that's come up is the mental stress for everyone dealing with social isolation, family, or financial pressures as an impact of the virus on our society. It is important to stay in touch with your places of worship, friends, family, and co-workers so we can all stay "connected"

COVID TESTING IN TEXAS

As of April 29th, over 300,000 people have been tested, with the vast majority of tests performed by private labs. Total statewide positive case count stands at 26,171 in 207 of Texas' counties as of that date with 690 deaths statewide. Harris County has 5,986 positive cases to date. Almost 2,000 of those cases are from residents who live in the Northwest Quadrant of the County.

Reopening Texas Businesses: Governor Abbott issued the order allowing limited reopening of specific businesses effective May 1st. Some businesses like restaurants will likely choose to remain closed due to the 25% capacity rule. I'm sure it takes a larger capacity in some cases to reach a "break-even" point in covering their overhead. Barbershops, hair and nail salons have been authorized to open on May 8th, and others like gyms can open May 18th, providing they all adhere to the reasonable health precautions outlined by Texas Department of State Health Services and the Center For Disease Control. Factors that officials will consider before beginning Phase 2 will include hospitalization rates, coronavirus death rates, and if there are hot spots in different parts of the state.

As your State Representative, I continue to maintain contact with our county and state officials. I try to keep you posted on updates to news and announcements about local actions and state efforts to contain this virus. We know the full impact of this pandemic on families, businesses, as well as the State of Texas will not be fully realized for months to come. It is probably safe to anticipate some reduction in the State's revenues with the falling oil prices and lower overall production. Texas Unemployment Commission

As of April 27th over 9,000 residents in District 126 have filed unemployment claims

with Texas Workforce and I'm sure many more remain in processing. Over 57% of these claims have been from women, which tells us a lot about who is being affected. I know many of you have had your jobs affected by the pandemic and even more tragic is the backlog of people trying to file unemployment claims with the Texas Workforce Commission. In an effort to help, two of my employees donated their assistance to help with the problem. The Texas Workforce Commission is now open twelve hours a day, seven days a week, from 7am to 7pm and has been overwhelmed by unemployment claims, So far since March, they have taken 2.1 million claims and paid out 3.3 billion dollars. It is our hope, that as Texas begins to re-open and people get back to work, we will see a reduction in that backlog.

"The Texas Workforce Commission (TWC) encourages individuals previously deemed monetarily ineligible for unemployment benefits to reapply online starting Sunday, April 5, 2020. This date marks the beginning of a new quarter and as such the base period for unemployment benefits and those previously ineligible may now qualify."

TWC now has over 1,000 staff helping support unemployment insurance services and more staff is expected to be hired in each of its unemployment benefits call centers.

Testing Sites

In Houston and Harris County, there are currently 6 testing FEMA supported sites with a capacity of 1,400 tests per day with enough supplies to last 20 more days. There are many times more tests being done by private labs outside the public testing sites. Along with their two permanent and four mobile testing sites, Harris County has partnered with Walgreens to create two additional drive through testing sites. These

sites are a partnership project and are managed by Walgreens and results are available within 24 hours.

News For Harris County Precinct 4 Road And Capitol Project Update

The majority of Harris County's engineering staff and engineers of record are working

remotely from home on capital improvement projects in the Study or Design phase. Precinct 4 and the Harris County Engineering Department utilize various avenues of communication to maintain a projects schedule and technology promotes continued collaboration. The engineering community is able to communicate with the county's Project Managers and the decision making process or guidance during project development is not hindered.

Construction is considered an "essential" industry under the Stay Home, Work Safe Order; therefore, roadway construction efforts are ongoing.

Following are the capital improvement projects being pursued within District 126:

Construction Projects:

Following are the capital improvement projects being pursued within District 126:

- Congestion Mitigation Air Quality Project Phase 1A: Spring Cypress Road corridor between Telge Road and Louetta Glen Drive
- The Spring Cypress Rd corridor was a joint participation project between
 Harris County and the Texas Department of Transportation. Improvements
 included the installation of new traffic signals, battery-back up systems to
 existing traffic signals, turn lane extensions and installations, and fiber optic
 interconnect along the corridor. The project was deemed substantially
 complete on March 11, 2020. Construction cost: \$5,522,835
- Champions Drive from FM 1960 to Cypress CreekImprovements included upgrading Champions Drive, from a 2-lane asphalt roadway to a 2-lane concrete pavement section with an improved drainage system. The roadway was opened to the traveling public the first week of April 2020 and the Contractor remains onsite to complete remaining work items. Installation of the landscape plantings should start within a few weeks. This is a Joint Participation project between Harris County Precinct 4 and Champions Municipal Utility District.

Projects in the Study/Design Phase:

 Holderrieth Road Section 3 between Hufsmith-Kohrville Road and SH 99 at Champion Forest Drive: The Holderrieth Road project is currently in the Study Phase and a timeline to continue project development including the construction effort has not yet been determined. The funding source for the project is Harris County, and the estimated cost of construction is TBD.

1. Hufsmith-Kohrville Road Segment 2 between Hollow Glen Lane and Ezekiel Road

 Planned improvements include upgrading the corridor as a 4-lane concrete boulevard with improved drainage accommodations, traffic signalization at Lacey Road and Ezekiel Road, and all components necessary for realizing a complete project. The Project is currently in the Design phase and Harris County will bid the project for construction purposes upon completion of project development.

1. Hufsmith-Kohrville Road Segment 3 between Ezekiel Road and Holderrieth Road

 Planned improvements include upgrading the corridor as a 4-lane concrete boulevard with improved drainage accommodations, traffic signalization at Woodland Shore Drive, and all components necessary for realizing a complete project. The Project is currently in the Design phase and Harris County will bid the project for construction purposes upon completion of project development.
