Special Session #3 Finally Reaches Sine Die

This special session has primarily been about redistricting the boundaries for our Congressional Districts, our state Senate, House Districts and the State Board of Education. I'm sure this is always a challenging process and this year is no different. Especially with new mapping tools and new technology, it's pretty complicated to start with. The session wrapped up just after midnight on October 19th after passing property tax relief in **Senate Bill 1** and **Senate Joint Resolution 2**, both authored in the Senate by Senator Paul Bettencourt. The bills would increase the homestead exemption from twenty five thousand to forty thousand. The property tax relief will be covered out of the state's \$4.4 billion surplus and the proposed amendment will be on the May 2022 ballot for voter approval. Also passed late last night was the dog restraint bill Senate Bill 5, Congressional Redistricting in Senate Bill 6, and supplemental appropriations from the American Rescue Plan Funds in Senate Bill 8. All of these bills are covered below.

Redistricting, Federal Appropriations, and More

The Governor's Priority Agenda items for the third Special Session included:

Legislation relating to the apportionment of the State of Texas into districts used to elect members of the Texas House of Representatives, the Texas Senate, the State Board of Education, and the United States House of Representatives.

House Bill 1 - Changes to the district boundaries for the Texas House of Representatives. This bill passed both chambers and is on the way to the Governor.

<u>Senate Bill 4</u> - Changes to the district boundaries for the Texas Senate. This bill passed both chambers and is on the way to the Governor.


<u>Senate Bill 7</u>- Changes to the boundaries for the State Board of Education. This bill passed both chambers and is on the way to the Governor.

<u>Senate Bill 6</u> - Changes to the boundaries for the United States House of Representatives. This bill passed both chambers and is on the way to the Governor.

Our goal in determining Texas House districts is to have an area with about 190,000 residents with a deviation in voting precinct size that is less than 5% deviation from largest to smallest. We are required to use voting precinct lines, aligning a contiguous set of precincts into a district. I'm sure some constituents aren't happy about being moved to a new district, but with the rapid growth of our area, some dramatic shifts in representation have to be made, ultimately affecting representation for some.

Legislation providing appropriations from the American Rescue Plan Act of 2021 (ARPA), Pub. L. No. 117-2.

Senate Bill 8 - This bill directs appropriations from the Federal Government to various departments and programs within the state. The Texas Department of State health Services received \$2,462,085,730s from money received by this state deposited to the credit of the Coronavirus Relief Fund. The Governors Victims of Crime Fund received \$160,000,000, the Department of Criminal Justice received \$2,729,912,000, the Teacher Retirement System received \$286,337,761. The list of agencies and the amounts they received is in the link above. This bill passed both chambers and is on the way to the Governor.

Legislation identical to Senate Bill 29 as passed by the Texas Senate in the 87th Legislature, Regular Session, disallowing a student from competing in University Interscholastic League athletic competitions designated for the sex opposite to the student's sex at birth.

<u>House Bill 25</u> - Relating to requiring public school students to compete in interscholastic athletic competitions based on biological sex. This bill was voted on and passed in both chambers and is on the way to the Governor.

Legislation regarding whether any state or local governmental entities in Texas can mandate that an individual receive a COVID-19 vaccine and, if so, what exemptions should apply to such mandate.

House Bill 155 - Relating to exemptions from COVID-19 vaccine requirements. The bill filed by Dr. Tom Oliverson, State Representative from District 130 was heard in committee but did not advance any further.

Legislation similar to Senate Bill 474 as passed by the 87th Legislature, Regular Session, but that addresses the concerns expressed in the governor's veto statement.

Senate Bill 5 - Relating to the unlawful restraint of a dog; creating a criminal offense. This bill placed specific definitions and conditions in proper care and restraint of dogs. The bill has passed both chambers and is awaiting the Governors signature before becoming law.

Bail Reform

Providing additional protections for the victims of crime and the community in a bail bond reform measure through a constitutional amendment was among the items added after the third special session had begun. A bail bond reform statute was passed in the second special session but the constitutional amendment with it failed to get the super-majority vote required for it to pass. The same measure filed in Senate Joint Resolution 1, once again failed to gain the 100 votes necessary to pass the House during this special session.

\$160 million to the Trusteed Programs within the Office of the Governor for grants to crime victims

\$150 million to deploy reliable next-generation 9-1-1 services

\$100 million to the Texas Department of Agriculture to provide supplemental funding to food banks in response to the COVID-19 pandemic

SB1& SJR 2 HOMESTEAD EXEMPTION INCREASE

SB 1 & SJR 2 delivers property tax relief to Texas homeowners by proposing a constitutional amendment increasing the the residence homestead exemption from property taxes levied for public school purposes to \$40,000.

SB 52 CAPITAL IMPROVEMENTS FOR HIGHER ED

SB 52 authorizes the issuance of \$3.3 billion in bonds for capital improvement projects at public higher education institutions.

SB 5 UNLAWFUL DOG RESTRAINTS

SB 5 revises dog restraint requirements to ensure that dogs are restrained in a humane manner while minimizing the burden of compliance on owners.

HB 25 PROTECT UIL SPORTS

HB 25 protects girls' UIL sports in Texas schools by ensuring girls are not forced to unfairly compete against boys.

HB 133 HIGHER ED BENEFITS FOR SURVIVORS

HB 133 expands the eligibility for higher education benefits to certain adult child survivors of public servants.

REDISTRICTING

HB 1 modifies the composition of districts for the Texas House of Representatives.

SB 4 modifies the composition of districts for the Texas Senate.

SB 6 modifies the composition of districts for members of the United States House of Representatives from the State of Texas.

SB7 modifies the composition of districts for the State Board of Education.



Tragedy Strikes Close To Home



October 16 saw an horrific day for Precinct 4 Constable Mark Herman's Office. For the first time in its history, three deputy Constables were shot during a single incident. While working an off-duty job, the three deputies responded to

a disturbance and were ambushed from behind. All three deputies were shot by an assailant from behind, killing Deputy Atkins and wounding the two others.

Funeral services at Champion Forest Baptist Church and the procession brought out hundreds of fellow peace officers and community members to pay their respects as Deputy Atkins was laid to rest. Keep his family and coworkers in your thoughts and prayers as they deal with the grief and loss.



Operation Lone Star

A number of people have commented in emails and phone calls on our situation at the border and many are probably wondering about the actions and resources we are using to protect our Southern border. The number of undocumented immigrants found crossing our border rose from 180,000 in June to 200,000 in July and along with them come inherent challenges of crime and community health. The Department of Pubic Safety's efforts cost a little over two million dollars a week in manpower and resources.

During an interim hearing for Homeland Security and Public Safety, we heard from both the Steve McGraw, the Director of the Texas Department of Public Safety and representatives from the Texas Department of emergency Management about their efforts along the border.

Since March, the DPS has deployed 500 Troopers to assist the U. S. Border Patrol and the National Guard. The Texas National Guard has also deployed 1,000 members of their forces, along with officers from Nebraska, Florida, Iowa and Ohio have also come to assist in "Operation Lone Star". Working with the border Sheriff's, Chiefs of Police, who are familiar with their own local jurisdictions, and our federal partners, their role is to augment the personnel and resources targeting illegal activity at the border. According to statements made during testimony, this massive influx of people crossing the border presents a significant security threat to our state.

According to news briefs provided by the DPS this surge in immigrant flow across the border has been accompanied by a commensurate increase in criminal activity. From March to mid-October there has also been a significant

amount of drugs seized, including 1,500 pounds of cocaine, 130 pounds of fentanyl, 10,000 pounds of marijuana, 1,500 pounds of meth and 34 pounds of heroin. They also seized \$3.8 million in currency. There have also been 272 firearms seized, including high powered rifles and military grade weapons that are crossing the border to supply the cartels."

During this same time frame, there were over 73,000 migrant apprehensions and referrals to Border Patrol.

During testimony during the hearing from a mayor of a border municipality, it was revealed that no Covid testing was being done for those crossing and being released further increasing the risk of virus spread into the community.



Our mission is to serve Texas by our stewardship of natural resources and the environment, our concern for personal and community safety, and our support of enhanced development and economic vitality for the benefit of Texans.

RRC Staying Ahead of the Game for the Upcoming Winter

While the RRC continues implementing legislation to help fortify the state's energy supply, our staff is also taking proactive measures for Winter 2021-2022.

As operators come off the summer season and prep for winter operations, the Commission issued a Notice to Operators asking gas facility and gas pipeline facility operators to take all necessary actions as they prepare to operate during winter season 2021-2022.

We have sent notices to operators a couple of times this month reminding them of updating their information with their electric providers for critical load serving electric generation.

RRC staff also began site visits to observe winter preparedness of operators as they come off summer operations; we plan to complete between 15,000-20,000 of such visits before the end of the year.

RRC Continues Strong Track Record of Inspections

By setting annual performance goals, the Legislature holds the RRC to high standards to ensure protecting public safety and the environment.

In Fiscal Year 2021, the RRC out-performed goals in the rigorous inspection programs over various industries we regulate – and gas, intrastate pipelines, alternative fuels, and surface mining of coal.

Inspections are critical to preventing pollution, protecting residents, and even the safety of activities such as weekend barbecuing with the use of propane.

ESD 11 Update - By Jerry Thomas

On October 28 at 1:55 pm, ESD 11 reached 10,000 incidents, resulting in 5,636 transports since beginning service on September 1, 2021. Additionally, October 25 was a milestone day here in NW Houston. On this day, we received our 40th ambulance in just eight months.

Our partners REV Group, Inc., American Expedition Vehicles - AEV, and Southern Emergency & Rescue Vehicle Sales, have been exceptional and have worked well together to help us fulfill our promise to the ESD11 community. Despite COVID, workforce shortages, chip shortages, supply chain issues, stolen catalytic converters, and the impossible task of procuring new vehicles in today's market, this hard-working PARTNERSHIP made it happen.

We have completed our second new-hire orientation and are excited about adding 28 additional employees to the organization. In addition to completing this hiring session, we continue to interview and plan for a third hiring session in December.





The chart above provides a reflection of the trend for new COVID-19 cases reported for all of Harris County.







Commissioner Redistricting Takes a Dramatic Turn

In lieu of the regular monthly capitol project update, we thought it would be more informative to ensure everyone is aware of the somewhat radical changes for representation of our area of the County. Last Thursday, Commissioner's Court approved a re-districting plan along party lines, created by Commissioner Rodney Ellis, that essentially "flips" precinct 3 and precinct 4. For those of you who have previously been provided services from Commissioner Jack Cagle, may now find yourself in Commissioner Tom Ramsey or Commissioner Rodney Ellis' precinct service area.

Changes to these service areas will take effect after the 2022 General Election and a copy of the approved map is below.


