# 88th Session - Midpoint

We are about at the mid-point in this session and the pace of activity has definitely increased. Hearings are progressing in all of our committees and we are beginning to address some of the priority items for this session.

Property Taxes There are a number of bills addressing "property tax relief" in both chambers this session. On the 22nd of March, the Texas Senate's \$16.5 billion Property Tax Relief Plan was voted out of the Senate unanimously. Senator Bettencourt's **Senate Bill 3, Senate Bill 4, Senate Joint Resolution 3** and Senator Parker's **Senate Bill 5** passed out of the Senate on a bipartisan vote. These measures raise the homestead property tax exemption to \$70 thousand, affecting 5.72 million homes in Texas. SB 3 also increases the homestead exemption from \$25 thousand to \$40 thousand for all over 65 disabled homestead owners. Senate Bill 5 would cut \$1.5 billion in business property taxes. All four of the bills were voted out and received by the House.

House Bill 2 offers a different approach and would provide for a \$0.15 reduction in a public school district's maximum compressed tax rate for the 2023-2024 school year. If a district's maximum compressed tax rate after that reduction would be less than 90 percent of another district's maximum compressed tax rate, the district's maximum compressed tax rate is instead the value at which that rate would be equal to 90 percent of the other district's maximum compressed tax rate. HB 2 also makes the exemption applicable to any qualifying residential homestead. HB 2 would lower school property taxes an estimated 28% as well as reduce the limit on annual appraisal increases to 5%, limiting "surprise billing" kinds of tax bills. The House bill was voted out of committee and is on the way to a floor calendar.

#### **School Safety**

There are likewise a number of bills this session that address school safety, particularly in expanding mental health into our rural communities and limiting access to "assault style" weapons with large magazine capacity to young adults under the age of 21, or restricting the purchase of those magazines before that age. Among the bills being considered are:

<u>House Bill 3</u> (Burrows) This is a bill to address the overall safety programs and associated funding, accompanied by safety audits, requirements for armed security officers, building standards and required coordination between local law enforcement and school police. Required to meet twice annually, the law enforcement groups are to discuss collaboration, limitations on capabilities, chain of command, and communications for interagency activities.

<u>House Bill 165</u> (Johnson, A.) This bills seeks to create a specific offense for a "mass shooting" as a part of a an event where an attempt is made to kill or injure four or more people in a single incident.

<u>House Bill 1760</u> (Hefner) This bill creates an offense for possession of a weapon on a school or post-secondary school facility or property owned, or controlled by the school.

<u>House Bill 2454</u> (Guillen) HB 2454 creates a state offense for purchasing a weapon for someone prohibited by state or federal law from possessing one. (Straw purchase)

#### **Border Security**

Crime around and associated with the border remains a serious concern for many of the people in our area. The volume of weapons, illegal drugs, and violent crime continues to increase and there seems to be no immediate end in sight. The legislature is taking action to address this increase in crime through a number of different bills. Among the bills being considered in the House are:

House Bill 884 (Harless) There are dozens of different federal agencies that assist state and local law enforcement in a variety of roles. Federal agents of the FBI, Secret Service, and even ICE has the powers of a Texas Peace Officer to arrest and file criminal charges in this state, but the US Border patrol, a sister agency to ICE under the Homeland Security Administration does not have the authority to charge suspects who violate serious criminal offenses and have to call a local officer when they encounter drug couriers, human traffickers, or those with weapons. This bill would give peace officer status for Border Patrol to file charges for felony offenses.

<u>House Bill 2883</u> (King) In order to address rampant importation of weapons and illegal drugs coming in through our Western border at new Mexico, Representative King proposes that the Texas DPS establish a border checkpoint program to monitor interdict the flow of narcotics on our highways coming from the West.

#### **Committee Activity**

#### Select Committee on Public Healthcare Reform

The Public Healthcare Reform Committee has met a few times and has heard several high profile bills. Some of them reflected priorities and recommendations from our committee report during the interim from last year. We currently have 68 bills assigned to this committee.

House Bill 12 ((Toni Rose) which deals with extending postpartum Medicaid coverage from 6 months to 12 months. This measure passed the House last session but was reduced to 6 months under budget considerations in the Senate. The bill has considerable support with a host of joint and co-authors and Representative Harless was proud to be a co-author on this important bill.

<u>House Bill 1599</u> (Bucy) This bill was a recommendation from the committee report last year and is also joint authored by Representative Harless. it creates an express lane process for eligibility determination across Medicaid programs administered by the state. This bill was voted out of committee.

<u>House Bill 617</u> (Frank) This bill creates a pilot project to establish telemedicine programs in rural parts of the state or in large less populated areas. This bill was voted out of committee.

Homeland Security & Public Safety

There are a wide variety of issues in the bills assigned to this committee, most deal with public safety and/or law enforcement. There are 152 bills currently assigned to this committee. Here are a few of the highlights.

<u>House Bill 767</u> - (Harless) This is one of our bills that includes the offense of "stalking" in the list of offenses that require entry into the statewide law enforcement computer system when a defendant is released by a judge with a bond that has conditions. This improves the safety of the victim and law enforcement that have to respond to domestic disturbances. This bill was voted out of committee will go to the full House for a vote.

<u>House Bill 1152</u> (Vo) This bill would allow for non-residents (not US citizens) who have honorably served in the US Military, to apply for peace officer positions in Texas. This does not assure employment but does remove the existing obstacle of US citizenship. This bill is still pending in committee.

House Bill 1275 (Plesa) This bill provides for holders of a Texas Driver's License who are 65 years of age, or older, to voluntarily surrender their license and replace it with a Texas Identification Card through an on-line process. This basically mirrors the portal used to renew a license on-line. This bill is still pending in committee.

#### Community Safety Committee (Select)

Speaker Dade Phelan created this committee in response to the school shooting last year in Uvalde and charged the committee with reviewing all legislation dealing with guns, ammunition, and gun magazines for this session. The committee is comprised primarily with most of the same members as the Homeland Security & Public Safety with the addition of a few others. Full committee <a href="mailto:membership here">membership here</a>. The committee alternates hearings with Homeland Security and they currently have 135 bills assigned to this committee.

<u>House Bill 165</u> (Johnson A) This bill creates a specific category of offense related to "mass shooting" events". The criminal charge could be filed in addition to any other related charged filed as a result of the offense and conviction of this offense would run concurrently. This bill is still pending in committee.

<u>House Bill 636</u> (Patterson) This bill would allow for election judges to carry a handgun at a polling location at either early or election day voting. This bill is still pending in committee.

# Cypress Creek Drainage Improvement District

#### **Progress Report**

After months of work with representatives from the Cypress Creek Flooding Task Force and the Cypress Creek Flood Coalition and the Texas Legislative Council, we now have drafted language that is now filed as <a href="House Bill 5334">House Bill 5334</a>. This effort began through an interest by the community to increase awareness on flood mitigation projects and increase involvement and input directly from our area.

Continued development in the Northwest parts of Harris County around Katy, Hockley, and Cypress will continue to exacerbate downstream flooding for years to come. Due to Harris County's changing prioritization for flood mitigation projects, the projects in the Cypress Creek Watershed have not received sufficient funding.


Our commitment to pursuing this effort has always been conditional in that the district would not have the authority to impose taxes or issue bonds. Our homeowners and seniors are already burdened with high property taxes and appraisals. The district must acquire funds through donations, grants, or appropriations of state or federal funds from other sources. Our Facebook poll on this subject remained active for over a week and had over 300 participants. Just over 72% of those supported the creation of a district under those conditions. The district would have four years to acquire sufficient funding to hold an election for a permanent board, or the district would be dissolved.

When compared to size, the Cypress Creek watershed is among Harris County's largest, containing 267 square miles and having 250 miles of waterways and tributaries. According to the watershed <u>reference page</u> published by the Flood Control District, the area has a population of 347,000. It extends from Waller County, Southeast along the 1960 area, across I-45, eventually reaching Lake Houston.


This area has been subjected to numerous extensive flood events over the last several years, the most recent floods brought by Hurricane Harvey in 2017 devastated much of this area, flooding homes, businesses, even assisted living centers. Of the 120,000 homes destroyed by Harvey, much of that damage was felt along the Cypress Creek Watershed.

The bill was referred to the Natural Resources Committee on April 4th and we will be requesting a hearing in the coming days.



#### HCESD 16 News

Klein Fire Department has continued to see an increase in calls in the first few months of 2023, with a 15% increase between January and February. Last month, we responded to a total of 310 dispatched incidents in our territory – 19 of which were fire-related and 147 of which were rescue and/or EMS incidents. More than half of the responses were concentrated among three stations – Station 32 (20%), Station 33 (17%) and Station 34 (15%).

#### **Lithium Battery Do's & Don'ts**

Fire departments across the country have seen an uptick in lithium-ion battery fires. These types of fires are very dangerous – they can be explosive, are fast moving, and don't go out easily. Causing extensive damage and numerous injuries, these "pockets of fire" remain even after appearing to be extinguished; meaning firefighters must stay for hours to ensure the fire doesn't reignite or escalate.

When a lithium-ion battery fire starts, the escalation is rapid. They usually take you by surprise, leaving very little time to escape and consume everything in sight. These fires tend to start due to overheating, but may also be caused by defective batteries. Complications with these fires create an "unstoppable chemical reaction" called a thermal runaway. They are so hard to stop that typical household fire extinguishers cannot put them out.

What is a lithium-ion battery? Well, we use them on a daily basis. They power our cell phones, wearable tech like smart watches or ear buds, laptops and tablets, implanted medical devices, portable power banks, cordless power tools, and electric scooters, bikes, and cars. Essentially, anything we plug in to charge is an item we should use with respect and caution.

Klein Fire Department responded to a devastating fire believed to be caused by a lithium-ion battery. We were first-in on a residential structure fire in Station 31's zone, with no obvious signs of fire upon arrival. As our members advanced with a handline through the front door and called out for signs of life, the acting captain heard a response, calling for help. The team quickly moved in the direction of the plea and found a badly burned person, removing them from the residence. Harris County ESD 11 Mobile Healthcare transported them to the hospital.

As a team, Engine 31 worked together to preserve life and property, courageously saving a life in the process. Mutual aid to extinguish the fire and secure the scene was provided by Ponderosa Fire

Department, Champions Emergency Services District, and the Harris County Sheriff's Office. While accidents happen, being mindful of the possible dangers of everyday items that use lithium-ion batteries is in the best interest of community members. Practicing safe storage and charging and recognizing defective or tampered-with batteries will greatly assist in the decrease of lithium-ion battery fires.







The Klein Fire Department is rated ISO Class 2 and provides Fire Suppression, Rescue, and Medical Emergency Assistance to a resident population of 173,549 residents covering the Spring/Klein area and encompassing approximately 49 square miles.

**Plan Ahead!** If a fire breaks out in your home, you may have only a few minutes or seconds to get out safely once the smoke alarm sounds. Everyone needs to know what to do, how to get out, and where to go if there is a fire.

#### BE PREPARED...

- · Make a **PLAN**. Draw a map of your home. Show all the doors and windows.
- Know at least 2 WAYS OUT of each room, if possible. All windows and doors should open easily.
- SMOKE ALARMS Have them and test them.
- Have a **MEETING PLACE** outside. It should be in front of your home, and EVERYONE should meet here.
- PRACTICE your plan twice a year, during the day and at night, and practice different ways out.
- TEACH children how to escape on their own in case you can't help them.
- · CLOSE DOORS behind you as you leave.

#### IF THE ALARM SOUNDS...

• GET OUT AND STAY OUT! Never go back inside for people, pets, or anything else.

- GET LOW AND GO under the smoke to your way out.
- Call 9-1-1 from **OUTSIDE** your home.

#### Ready Harris Accessible Alerts

The Harris County Office of Homeland Security& Emergency Management has launched the new Ready Harris Accessible Alerts (RHAA). This new system is providing access to alerts, warnings, and preparedness information to persons who are Deaf, Blind, Hard-of-Hearing, Deaf-Blind, or have low-vision through a new one-stop-website. To sign up, we encourage members of the community to visit <a href="https://hct.ahasalerts.com">https://hct.ahasalerts.com</a>.

Community members can also text AHAS to (281) 609-9093 to sign up.

The system will send our Ready Harris Alerts with sign language interpreting along with voice and closed captioning in English and Spanish before, during and after an emergency. The RHAA is compatible with video capable devices such as computers, tablets, cell phones and wireless Braille readers. With this new resource, HCOHSEM will also be able to reach individuals with low literacy in English and Spanish. This is HCOHSEM's latest effort to reach the whole community.

Asphalt Reconstruction Package 2022-1 in the Cypress and Spring areas

Project Scope: Repaving of roads, new markings, and street signs along Tanner Road from Triway Lane to the Sam Houston Tollway, West Little York Road from North Eldridge Parkway to Brittmore Road, and Kuykendahl Road from north of Spring Cypress Road to north of 1960

Benefits: Increase safety and mobility throughout these areas

Phase: Construction

Atascocita Road at Blackstone Trails
Project Scope: Install new traffic signal

Benefits: Improves driver safety

Project Scope: Extend left turn lanes

Asphalt Reconstruction Package 2022-2 in the Humble and Crosby areas (STARTING SECOND QUARTER 2023)

Project Scope: To reconstruct various roads in Humble and Crosby. Roadway portions include Aldine Westfield Road, First Street in the Crosby area, Miller Wilson Road, Hare Cook Road, Ramsey Road, East

Stroker Road, and Krenek Road

Benefits: Increase safety and mobility throughout these areas

Phase: Design

Estimated Construction Cost: \$11.3 million

Crosby Township/MUD (Runneburg)

Project Scope: Subdivision drainage improvements and channel excavation

Benefits: Increased drainage capacity and reduced flood risk

Cypress Creek Estates Subdivision

Project Scope: Subdivision drainage improvements and pavement reconstruction

Estimated Construction Cost: \$9.4 million Completion: Second Quarter of 2023

#### Precinct 4's Infrastructure Division

The Infrastructure Division administers and manages Precinct 4's Capital Improvement Projects Program. The CIP program includes road expansion projects, traffic signals and intersection improvements, and traffic management systems designed to improve mobility and air quality.

The Infrastructure Division also oversees the Child Safety Fund which is used to provide warranted school zone flashing warning signals in compliance with Precinct 4's criteria, the installation of a warranted traffic signal system facilitating the movement of traffic around a school facility to promote student safety.
