

This important deadline also means that the House can begin passing bills that are not a part of Governor Abbott's priority items. On the next page, I have provided a list of all the bills that I filed this session.



From this point moving forward, we can expect much more debate on the House floor on some key pieces of legislation. Committee hearings have ramped up and we are close to finalizing the House version of the state budget in the House Appropriations Committee. #### **BILLS FILED FOR THE 86TH LEGISLATIVE SESSION**

The bill filing deadline for the 86th legislative session has passed and I am proud of the hard work my staff and I, along with community partners and constituents, have put into these meaningful pieces of legislation. Over the next few weeks, I will keep you up-to-date on the status of these bills as they make their way through the legislative process.

**HB 597** 

Makes an annual determination of a cost-of-living adjustment applicable to certain benefits paid by TRS to

ensure that when inflation rates increase, members and their beneficiaries are able to maintain financial security post retirement.

**HB 1124** 

Seeks to discourage insurance companies from simply paying nominal fees by holding insurance

carriers liable for damages to an insured if their out-ofnetwork policy benefits are ignored.

**HB 1718** 

Enables patients the ability to shop their medical costs through a public portal that lists contract

reimbursements. The bill provides transparency and mitigates surprise medical billing by containing out-of-pocket costs and increasing patient access.

**HB 2151** 

Will ensure that insurance plans are only seeking recoupment on claims that are actually overpaid by pro-

hibiting a health maintenance organization from conducting a sample audit and extrapolating those findings across the remaining un-reviewed portion of the claim.

**HB 2193** 

Will increase the current baccalaureate capacity at community colleges like South

Texas College from five to seven degrees to ensure that the state possesses the capacity to facilitate the growing need for skilled professionals.

**HB 2356** 

This bill would allow for overtime pay to be included in the computation of benefits

for DPS and Game Warden employees working overtime providing law enforcement services in counties along the Texas-Mexico border.

**HB 3228** 

Gives consumers the right to participate in the title insurance rate hearing process by

providing standing to the public to appear, offer evidence at rate hearings, and to request a rate hearing be held to consider a rate change more frequently than five years.

#### **HOUSE APPROPRIATIONS UPDATE**

Earlier this week, the House Appropriations Committee adopted several riders meant to improve overall state functions and provide additional revenue for local grants. With the markup process complete, we will consider the committee substitute for HB 1 in the upcoming week, which will draw us closer to the infamous "budget night".

Some of the riders include:

- Additional funding for border prosecution grants;
- Local grants for eligible non-profits to promote border economic development;
- An appropriation of \$1,000,000 for grants to professional fire departments in the border region to assist in the acquisition of specialized equipment, maintenance, and medical supplies to support emergency services associated with the execution of security activities in the border region;
- An additional 2 million dollars to provide grants to reimburse district attorneys for costs associated with testing forensic evidence;
- An additional appropriation of \$3,000,000 for veterans treatment courts grants;
- \$500,000 to establish pilot programs that work with juveniles at the Juvenile Justice Department to provide trade skills and counseling to reduce recidivism;
- Increase appropriations to prioritize the testing of Sexual Assault Kits and Improve Crime Lab Services at the Texas Department of Public Safety labs.
