

Representative Muñoz addressing the media at a press conference held by the Texas Democratic Party regarding the Border Wall.




BILLS CO-AUTHORED FOR THE 86TH LEGISLATIVE SESSION

The deadline for bills to pass on 2nd reading in the House has passed and I am proud of the hard work my staff and I, along with community partners and constituents, have put into these meaningful pieces of legislation. Along with the bills I authored, I have also teamed up with colleagues to pass other meaningful pieces of legislation!



HB 2193 by Rep. Muñoz


It increases the current baccalaureate from five to six to create a Bachelor of Applied Science in Public Safety Management. The program will focus on public safety, homeland security, fire science, and emergency management.





HB 2340 by Rep. Dominguez

HB 2340 improves disaster management and encourages federal-state partnerships to reduce red tape and streamline federal policies to be better prepared for future disasters



HB 342 by Rep. Cortez

Children in Medicaid are subject to multiple income checks each year, and too many lose coverage even though they remain eligible. This bill would give Medicaid kids the same 12-month coverage that higher-income children on CHIP get.

HB 361 by Rep. Israel

Texas is one of 12 states that doesn't allow online voter registration. This bill would allow Texas residents to register to vote online, making it more accessible to be elible for them to cast their votes.

ANOTHER \$500 MILLION PROJECTED FOR STATE BUDGET



Comptroller Glenn Hegar recently announced that based on changes in estimated revenue collections for this fiscal year, the projected ending balance of revenue available for general-purpose spending experienced an increase of \$518 million from the January 2019 Biennial Revenue Estimate. Some of the increased revenue projected for fiscal 2019 is attributable to upwardly revised estimates of oil and natural gas production tax collections. With this increase, we now expect our Economic Stabilization Fund to have a balance of \$15.62 billion at the end of the 2020-21 biennium.
