LEGISLATIVE UPDATE

The bill filing deadline is behind us — and I'm happy to report that I officially authored and filed 47 pieces of legislation this session, all on issues that are important to you and your family, our businesses, our community and the entire state. From healthcare to education, taxpayer protections to public safety, safeguarding our fundamental liberties and freedoms, investing in infrastructure, ensuring our courts are open and accessible and strengthening the Texas economy, I and my team are working hard to be your effective advocate and voice in the Texas House. Our days at this point in session are filled with bill layouts, committee hearings, meetings with fellow legislators, stakeholders, experts and, of course, communications with YOU, the people I am elected to serve. I want to thank everyone who either is taking part in the legislative process along with us, including many who have traveled to the Capitol to testify on a bill in person or who have registered testimony in our new online Texas House Public Portal. I remind you – the Texas House is your House ... and you and your voice are always welcome and needed in the legislative process.

This past Monday I had the privilege to layout a bill that is near and dear to me to the House Committee on Culture, Recreation and Tourism. An idea brought to me by my good friend, constituent and veteran Matt Foster, House Bill 1341 has a great, great purpose. If passed, this bill will provide free entry to each of Texas' beautiful State Parks for all active military, veterans (regardless of service-related disability rating) and first responders, including our firefighters and police officers. These are the men and women who serve on the front lines, protecting us, protecting our communities and our homes ... frequently putting their very lives on the line to protect us and preserve our freedoms. This is a small token but a big expression of our gratitude to them for all they do for us,.

Also, last week I filed <u>House Bill 3775</u> which would protect taxpayer dollars by curtailing outrageous public employee severance packages, commonly known as "golden

parachutes," especially when there has been termination of that official because of misconduct. It is high time that government officials stop padding their own pockets at the expense of the Texas taxpayer. Terminated public employees, especially those entangled in scandal, should not receive excessively hefty severance packages while taxpayers struggle. Bottom-line: hardworking Texans deserve better.

BIG CHANGES!

COVID-19 Vaccine Update: In addition to front-line healthcare workers and people over the age of 65, those that are between 50-64 years of age as well as school and licensed child care personnel are now eligible to receive the COVID-19 vaccine. Drivers License Waiver Period Ending:

The grace period for expired driver's licenses and ID cards ends on April 14, 2021. DPS encourages customers who need to renew their license and ID cards to schedule an appointment at their local driver's license office. 
Collin County Association of Realtors
