88TH LEGISLATIVE SESSION RECAP

Through dedication and collaboration, we delivered legislative priorities in healthcare, education, technology, mental health, senior care, and animal welfare. These accomplishments reflect our shared commitment to building a better future for all Texans.

Healthcare Improvements

Healthcare was a key priority this session. I was able to include several state budget riders in HB 1, including the Strategic National Stockpile for Health Emergency Preparedness, enabling federal funds to build a medical supply stockpile and prepare Texas for public health crises. Additionally, the Family Practice Residency Program Budget Rider allocated an additional \$5 million biennially to retain Texas-trained physicians, addressing critical shortages.

The Postpartum Medicaid Expansion, HB 12, extended Medicaid coverage for new mothers from two to 12 months, ensuring vital medical and mental health support. The Importation of Prescription Drugs from Canada, HB 25, reduced medication costs, enhancing affordability. Other highlights include the Next Generation 9-1-1 Telemedicine Project, HB 617, which enhances emergency care in rural areas, and HB 916, which ensures Medicaid users receive a year's supply of contraception in one prescription. SB 840 increased penalties for assaults on hospital personnel, while SB 989 expanded biomarker testing coverage, improving diagnosis and treatment for complex diseases.

Educational Advancements

Significant advancements were made in education. The Community College Finance Bill, HB 8, improved transparency and affordability. HB 1212 and HB 1883 ensured religious observances are accommodated in academic schedules. Competency-based education gained momentum through HB 4005, which allows students to earn credit for real-world experience, while HB 4363 offered scholarships for future educators in critical shortage areas.

School safety was addressed with SB 838, known as Alyssa's Law, mandating panic alert systems in classrooms. Additionally, SB 294 expanded access to lifesaving respiratory medications for students.

Mental Health Initiatives

Mental health remained a top priority. The Behavioral Health Innovation Grant Program, SB 26, expanded mental health bed capacity and improved care provided by local authorities. The Mental Health Loan Repayment Assistance Program, SB 532, reduced service obligations for mental health professionals, encouraging them to remain in Texas. This legislation also requires campus tours to include a visit to mental health clinics, expanding access to resources.

Technology and Infrastructure

This session propelled Texas to the forefront of technological innovation. The Texas Data Privacy and Security Act, HB 4, strengthened personal data protections, ensuring businesses meet high security standards. Broadband access expanded through HB 9 and SB 1238, connecting millions of Texans. HB 2060 created the AI Advisory Council, overseeing the ethical development of artificial intelligence, while SB 768 required timely notifications for data breaches, enhancing consumer protection.


Support for Seniors

Significant advancements improved the quality of life for seniors. HB 54 increased the personal needs allowance for long-term care residents. HB 568 mandated Alzheimer's training for peace officers, improving community safety and understanding. HB 1275 simplified driver's license renewals for seniors with mobility limitations, while HB 1673 introduced Alzheimer's care training for assisted living staff, ensuring residents receive tailored care.

Strengthening Animal Welfare

Animal welfare saw improvement with SB 876, which reformed the Texas Licensed Breeders Program, enhancing standards and combating unethical practices.

89TH LEGISLATIVE SESSION PREVIEW

As we embark on the 89th Legislative Session, our office remains steadfast in our commitment to addressing the key challenges facing Texans today. From ensuring access to quality healthcare and promoting public safety to fostering educational opportunities and protecting consumer rights, we are focused on advancing thoughtful and inclusive solutions that benefit every corner of our community. This session also brings a renewed focus on building resilience in our infrastructure and environment to better prepare for the challenges of tomorrow. The following are just a few of the priorities we are pursuing this session. Together, these initiatives represent our office's dedication to creating a healthier, safer, and more equitable Texas for all.

Healthcare Initiatives

Healthcare reform is a cornerstone of our legislative agenda, focusing on expanding access to Medicaid and developing innovative solutions to support low-income Texans. Our proposals aim to address the needs of those with critical health conditions by improving eligibility standards and expanding health benefit options. We are also prioritizing equitable care by strengthening emergency medical services, such as dialysis treatments for individuals with end-stage renal disease and establishing critical health and safety protocols for assisted living facilities. These reforms aim to provide better resources for caregivers and enhance emergency preparedness, ensuring that all Texans receive the care they need when they need it most.

Public Safety and Responsible Gun Ownership

Strengthening public safety is a top priority this session. Our office is advancing legislation to promote responsible gun ownership and protect communities by addressing firearm accessibility and transfers, enhancing background checks, and implementing stricter penalties for violations. Through bipartisan collaboration on common-sense measures, we aim to reduce gun-related harm while respecting constitutional rights.

Consumer Protections

Protecting consumers from unfair practices is essential. Proposed legislation seeks to ensure transparency in subscription service agreements by requiring clear terms and the ability to cancel services without excessive hurdles. We are also pursuing measures to shield families from the burden of having medically necessary debt reported on credit records, reducing financial strain during health crises. These efforts aim to empower Texans with fairness, financial security, and consumer rights.

Education and Inclusivity

Education reform is central to our legislative priorities, with a strong focus on fostering inclusivity and safety in Texas schools. Proposed legislation supports the development of a maternal healthcare workforce, improves bilingual resources and reporting mechanisms to address harassment and violence on campuses, and mandates dietary inclusivity in school meal programs. By addressing diverse needs, we aim to create learning environments that are safe and supportive for all students, regardless of background.


Environmental and Infrastructure Resilience

To prepare for future challenges, we are prioritizing sustainability and infrastructure resilience. A proposed study will explore the feasibility of burying power lines along the Gulf Coast to reduce weather-related outages and improve energy reliability. Additionally, enhanced air quality monitoring in industrial counties will increase transparency and accountability for environmental impacts. These initiatives are designed to promote cleaner air, better resource management, and stronger infrastructure for communities.

Support for Seniors

Our senior population deserves dignity and security, which is why we are introducing legislation to improve safety and care in senior living communities. Proposed measures include comprehensive emergency response protocols and clear guidelines for power outage management. These initiatives aim to address the unique needs of seniors, ensuring they can age with dignity and independence.

Storm Recovery Efforts in District 76




